NOTICE OF APPLICATION AND PRELIMINARY DECISION FOR TPDES PERMIT FOR INDUSTRIAL WASTEWATER

AMENDMENT

Permit No. WQ0005363000

APPLICATION AND PRELIMINARY DECISION. Golden Pass LNG Terminal LLC, P.O. Box 306, Sabine Pass, Texas 77655, which operates the Golden Pass LNG Export Terminal, a liquified natural gas regasification terminal facility, has applied to the Texas Commission on Environmental Quality (TCEQ) for a major amendment of their existing U.S. Environmental Protection Agency (EPA) National Pollutant Discharge Elimination System (NPDES) Permit No. TX0125067 in the first-time issuance of Texas Pollutant Discharge Elimination System (TPDES) Permit WQ0005363000 to remove Outfall 001; and add seven new outfalls (Outfalls 002, 003, 006, 007, 008, 009, and 010), and their associated wastestreams. Proposed Outfall 002 will discharge stormwater, certain allowable non-stormwater discharges, wastewater from firefighting activities, and potable water at an intermittent and flow-variable rate; proposed Outfall 003 will discharge stormwater and certain allowable non-stormwater discharges at an intermittent and flow-variable rate; proposed Outfall 006 will discharge treated domestic wastewater at a volume not to exceed a daily average flow of 30,000 gallons per day; proposed Outfall 007 will discharge process wastewater and utility and demineralization unit wastewater at a volume not to exceed a daily average flow of 620,000 gallons per day; proposed Outfall 008 will discharge stormwater, certain allowable non-stormwater discharges, and treated, potentially contaminated stormwater at an intermittent and flow-variable rate; proposed Outfall 009 will discharge stormwater, certain allowable non-stormwater discharges, and miscellaneous utility wastewaters at an intermittent and flow-variable rate; and proposed Outfall 010 will discharge fire pump test water at an intermittent and flow-variable rate. The TCEQ received this application on June 2, 2022.

The facility is located at 3752 South Gulfway Drive, in the City of Sabine Pass, Jefferson County, Texas 77655. This link to an electronic map of the site or facility's general location is provided as a public courtesy and is not part of the application or notice. The effluent is discharged directly to Sabine-Neches Canal Tidal in Segment No. 0703 of the Neches-Trinity Coastal Basin. The designated uses for Segment No. 0703 are primary contact recreation and high aquatic life use.

In accordance with Title 30 Texas Administrative Code Section 307.5 and TCEQ's *Procedures to Implement the Texas Surface Water Quality Standards* (June 2010), an antidegradation review of the receiving waters was performed. A Tier 1 antidegradation review has preliminarily determined that existing water quality uses will not be impaired by this permit action.

Numerical and narrative criteria to protect existing uses will be maintained. A Tier 2 review has preliminarily determined that no significant degradation of water quality is expected in Sabine-Neches Canal Tidal, which has been identified as having high aquatic life use. Existing uses will be maintained and protected. The preliminary determination can be reexamined and may be modified if new information is received.

The TCEQ Executive Director reviewed this action for consistency with the Texas Coastal Management Program (CMP) goals and policies in accordance with the regulations of the General Land Office and has determined that the action is consistent with the applicable CMP goals and policies.

The TCEQ Executive Director has completed the technical review of the application and prepared a draft permit. The draft permit, if approved, would establish the conditions under which the facility must operate. The Executive Director has made a preliminary decision that this permit, if issued, meets all statutory and regulatory requirements. The permit application, Executive Director's preliminary decision, and draft permit are available for viewing and copying at Port Arthur Public Library, 4615 9th Avenue, Port Arthur, Texas.

PUBLIC COMMENT / PUBLIC MEETING. You may submit public comments or request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit written or oral comment or to ask questions about the application. Generally, the TCEQ will hold a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

OPPORTUNITY FOR A CONTESTED CASE HEARING. After the deadline for public comments, the Executive Director will consider the comments and prepare a response to all relevant and material, or significant public comments. **The response to comments, along with the Executive Director's decision on the application, will be mailed to everyone who submitted public comments or who requested to be on a mailing list for this application. If comments are received, the mailing will also provide instructions for requesting a contested case hearing or reconsideration of the Executive Director's decision.** A contested case hearing is a legal proceeding similar to a civil trial in a state district court.

TO REQUEST A CONTESTED CASE HEARING, YOU MUST INCLUDE THE FOLLOWING ITEMS IN YOUR REQUEST: your name, address, phone number; applicant's name and proposed permit number; the location and distance of your property/activities relative to the proposed facility; a specific description of how you would be adversely affected by the facility in a way not common to the general public; a list of all disputed issues of fact that you submit during the comment period; and the statement "[I/we] request a contested case hearing." If the request for contested case hearing is filed on behalf of a group or association, the request must designate the group's representative for receiving future correspondence; identify by name and physical address an individual member of the group who would be adversely affected by the proposed facility or activity; provide the information discussed above regarding the affected member's location and distance from the facility or activity; explain how and why the member would be affected; and explain how the interests the group seeks to protect are relevant to the group's purpose.

Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for reconsideration or for a contested case hearing to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn. **If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law relating to relevant and material water quality concerns submitted during the comment period.**

EXECUTIVE DIRECTOR ACTION. The Executive Director may issue final approval of the application unless a timely contested case hearing request or a timely request for reconsideration is filed. If a timely hearing request or request for reconsideration is filed, the Executive Director will not issue final approval of the permit and will forward the application and requests to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

MAILING LIST. If you submit public comments, a request for a contested case hearing or a reconsideration of the Executive Director's decision, you will be added to the mailing list for this specific application to receive future public notices mailed by the Office of the Chief Clerk. In addition, you may request to be added to: (1) the permanent list for a specific applicant name and permit number; and (2) the mailing list for a specific county. If you wish to be placed on the permanent and the county mailing list, clearly specify which list(s) and send your request to TCEQ Office of the Chief Clerk at the address below.

All written public comments and public meeting requests must be submitted to the Office of the Chief Clerk, MC 105, TCEQ, P.O. Box 13087, Austin, TX 78711-3087 or electronically at <https://www.tceq.texas.gov/goto/comment> within 30 days from the date of newspaper publication of this notice.
