Re: Supplemental Notice - Commencement of Construction

Trailblazer Pipeline Company LLC and Rockies Express Pipeline LLC

Trailblazer Conversion Project Docket No. CP22-468-000

Dear Acting Secretary Reese:

On October 23, 2023, the Federal Energy Regulatory Commission ("Commission") issued an order ("Order") in Docket No. CP22-468-000, 1 granting a certificate of public convenience and necessity ("Certificate") to Trailblazer Pipeline Company LLC ("Trailblazer") and Rockies Express Pipeline LLC for authorization to abandon, construct, and operate certain facilities comprising its "Trailblazer Conversion Project."

On January 17, 2024, Trailblazer filed Bi-Weekly Construction Status Report No. 2 for the Trailblazer Conversion Project, which included, among other things, notification that project construction (civil grading) commenced during the reporting period (December 30, 2023 to January 12, 2024). Due to an administrative oversight, this report did not include the date construction commenced, which is required by Section 157.20(c)(1) of the Commission's regulations. Accordingly, the Applicants hereby provide this supplemental notice to the Commission that construction of the Project facilities commenced on January 4, 2024.³
